NOTICE TO THE MARKET

ZAMP S.A. (“**Company**”), in compliance with the provisions of Brazilian Securities Exchange Commission (“**CVM**”) Resolution No. 44, of August 23, 2022, as amended, hereby informs to its shareholders and the public in general that the Company’s Board of Directors, during a meeting held on this date, approved the second (2nd) issuance, by the Company, of commercial Notes, in one series (“**Commercial Notes**” and “**Issuance**” respectively), in compliance with CVM Resolution No. 160, of July 13, 2022, in force (“**CVM Resolution 160**”), having the following characteristics:

- **Total Issue Amount:** R\$125,000,000.00 (one hundred and twenty-five million reais).
- **Number of Series:** In a single series.
- **Resources Allocation:** The resources obtained as a result of the Issuance shall be destined to Company's ordinary business, including, without limitation, extend debt maturities, cash flow and/or capital expenditures (CAPEX).
- **Quantity:** 125.000 (one hundred and twenty-five thousand).
- **Guarantees:** No guarantees will be provided within the scope of the Issuance.
- **Term and Maturity Date:** Two (2) years from the Date of Issue.
- **Remuneration:** 100% CDI + spread of 2,60% (two integers and sixty hundredths percent) per year.
