("**Company**") hereby announces to its shareholders and to the market in general that, on this date, was concluded the Buyback Program of shares issued by the Company, approved by the Board of Directors on August 12, 2019, and subject to Material Fact in the same date.

The Company bought back the totality of the shares under the Buyback Program, which corresponds to 1,222,719 common shares representing approximately 0.54% of the shares issued by the Company, which shall remain hold in treasury, be cancelled and/or sold, mainly to support the Long-Term Incentive Plans approved by the Company. The average price of the acquired shares was R\$ 19.79.
